



HELPING BEYOND OUR BORDERS

As many of us resume our business-as-usual this week, Australia is still fighting the bush-fires, which have been ravaging the country for months and are now affecting lives, communities, wildlife and livelihoods. The people of Australia and their welfare remain at the forefront of our thoughts.

A total of 146 fires are burning across the state, with 65 uncontained, according to the NSW Rural Fire Service (NSWRFS).

About 2,700 firefighters were tackling the blazes on Sunday[1]. Australia's flag carrier Qantas canceled all flights to and from the country's capital, Canberra, on Sunday due to smoke and hazardous weather conditions[2]. Chris Dickman, an ecology professor with the University of Sydney, initially estimated that 480 million mammals, birds and reptiles have been affected by the wildfires in the state of New South Wales alone since September[3]

REVAMP OF FOREIGN INVESTMENT LAWS IN CHINA: MORE OPPORTUNITIES OR CHALLENGES?

The Foreign Investment Law contains largely policy statements with few details even though it seeks to regulate the activities of foreign investment and foreign-invested enterprises ("FIEs") in China. Foreign investors and FIEs in China should understand what the new regime is and what issues are yet to be resolved, so that they may know what opportunities and challenges they face with this new foreign investment umbrella legislation in China.

In conclusion although the Foreign Investment Law is seen more as a motherhood statement, China has sent out a clear and positive message that it continues welcoming and encouraging foreign investment in China and endeavors to create a more level playing field for foreign investment in China. There is no doubt that China intends to reduce restrictions for foreign investment and improve the ease of doing business in China. However, pending more implementation rules to clarify or supplement certain provisions in the Foreign Investment Law, we expect that there will be more opportunities, as well as certain continuing challenges, for foreign investment in China.
